The Help America Vote Act, or HAVA The Help America Vote Act says that all polling places must be accessible to voters with disabilities HAVA also says that you have a right to vote using a "provisional ballot" if your ability to vote is questioned A provisional ballot lets you say who you want to vote for, just like a regular ballot
