Some ingredients in beauty and cleaning products can irritate the skin leading to dermatitis (eg solvents in nail varnish removers). Some ingredients can cause skin allergies and asthma (eg liquids and powders in acrylic systems for artificial nails). Dust filings from artificial nails can cause wheezing, chest tightness and asthma.
